**A RESOLUTION TO AMEND THE TALBOT COUNTY COMPREHENSIVE WATER AND SEWER PLAN FOR THE PURPOSE OF ADDING OR MODIFYING THE TALBOT COUNTY CAPITAL PROJECT FOR FISCAL YEARS 2024 AND 2025 TO ADD A NEW CAPITAL PROJECT IN THE AMOUNT OF \$8.0 MILLION FOR THE PURPOSE OF REPLACING AND/OR REHABILITATING THE REGION V (TILGHMAN) SEWER COLLECTION SYSTEM TO MITIGATE INFLOW AND INFILTRATION**

**A RESOLUTION TO AMEND THE TALBOT COUNTY COMPREHENSIVE WATER AND SEWER PLAN FOR THE PURPOSE OF ADDING OR MODIFYING THE TALBOT COUNTY CAPITAL PROJECT FOR FISCAL YEARS 2024 AND 2025 TO ADD A NEW CAPITAL PROJECT IN THE AMOUNT OF \$8.0 MILLION FOR THE PURPOSE OF REPLACING AND/OR REHABILITATING THE REGION V (TILGHMAN) SEWER COLLECTION SYSTEM TO MITIGATE INFLOW AND INFILTRATION**

**WHEREAS**, the Talbot County Comprehensive Water and Sewer Plan (the “CWSP”) contains capital projects for water and sewer service in Talbot County, Maryland (the “County”); and

**WHEREAS**, the Region V (Tilghman) Wastewater System serves approximately 600 customers via 7.8 miles of sewer lines and force mains and up to five (5) major pump stations that convey wastewater to the Region V (Tilghman) Wastewater Treatment Plant; and

**WHEREAS**, the County Council of Talbot County (the “County Council”) desires to amend the CWSP for the purpose of including the capital project identified by the Talbot County Sanitary District for Fiscal Years 2024 and 2025 into Table 27 of the CWSP, entitled “Talbot County Region V Sanitary District (Tilghman Village) Capital Improvement Projects;” and

**WHEREAS**, in accordance with the requirements of Md. Code Ann., Envir. § 9-506(a)(1)(i), the proposed CWSP amendment set forth herein has been submitted to the Talbot County Planning Commission (the “Planning Commission”), as well as the Talbot County Public Works Advisory Board, for review for consistency with planning programs for the area; and

**WHEREAS**, on \_\_\_\_\_, 2023, the Planning Commission certified that the proposed CWSP amendment set forth herein is consistent with the Comprehensive Plan as required by Md. Code Ann., Envir. 506(a)(1)(ii).

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF TALBOT COUNTY, MARYLAND**, that the Talbot County Comprehensive Water and Sewer Plan shall be and is hereby amended as follows:

**SECTION ONE:** The above recitals are hereby incorporated as if fully set forth herein.

**SECTION TWO:** This project will add a sewer replacement and rehabilitation project to rehabilitate and/or replace sewer lines, rehabilitate and/or replace manholes, and raise roads elevations, when possible, to mitigate inflow and infiltration throughout the Region V (Tilghman) Gravity Sewer Collection System after funding has been obligated.

**SECTION THREE:** The Talbot County Sanitary District shall seek funding through the Maryland Department of the Environment (MDE) and the USDA Rural Development through grants and loan funding for the purpose of replacing and/or rehabilitating sewers and manholes along with completing road improvements to mitigate inflow and infiltration.

**SECTION FOUR:** The proposed sewer replacement and/or rehabilitation projects, along with road improvements, are needed to mitigate inflow and infiltration.

**SECTION FIVE:** The engineering estimate to complete all the work as presented in the project description is \$8.0 million.

**SECTION SIX:** Table 27 of the CWSP, entitled “Region V Sanitary District (Tilghman Village) Capital Improvement Projects,” shall be amended as follows:
