

## TALBOT COUNTY, MARYLAND

County Council MINUTES August 11, 2022

Present – President Chuck Callahan, Vice President Pete Lesher, Corey W. Pack, County Manager Clay Stamp, and County Attorney Patrick Thomas. Council members Frank Divilio and Laura Everngam Price joined the meeting via phone.

- I. Continuation of Presentation of Talbot County Economic Development Commission Recommendations for Funding of Talbot County Projects Through the Maryland Rural Economic Development Fund - Cassandra Vanhooser, Director, Department of Economic Development and Tourism; Reza Jafari, Chairman, Talbot County Economic Development Commission – Ms. Vanhooser stated that \$50 million in funding included in Governor Hogan's February 2022 budget was designated for economic development in Maryland's rural counties. She stated that each of the five regional councils in the state is to receive \$10 million; the Mid-Shore Regional Council, comprised of Caroline, Dorchester, and Talbot counties, will each receive \$3,233,333. She stated that ten members of the Talbot County Economic Development Commission volunteered their time to review and rank the 23 grant applications received, and the recommendations of the committee were presented to Council at their Tuesday, August 9, 2022 meeting. Mr. Jafari outlined the criteria by which applications could be considered for funding: economic development, workforce development, infrastructure, entrepreneurship and innovation. As she had done at the Tuesday, August 9, 2022 Council meeting, Ms. Vanhooser provided a brief outline of the projects recommended by the committee for funding, the amounts requested by the applicants, and the amounts recommended to be funded. As each of the projects was brought forward, Council discussion ensued and the amount recommended by the committee was accepted or modified. Several Council members requested that other projects be given consideration for funding and outlined the reasoning for their requests; Council discussion ensued. The projects presented for Council's consideration on Tuesday, August 9th were as follows:
  - \$257,500 Chesapeake College, Future Work Workforce Training Program
  - \$240,000 Maryland Broadband Cooperative, Mid-Shore Optical Broadband Network Upgrade
  - \$500,000 Avalon Foundation, Stoltz Pavilion
  - \$501,700 Town of Easton, Port Street Improvement Project
  - \$400,000 Eastern Shore Entrepreneurship Center, Ag Biotech Manufacturing Project
  - \$22,000 Talbot County Free Library, Digital Literacy and Employment Skills
  - \$87,133 Building African American Minds, Workforce Development Program
  - \$50,000 Talbot County Economic Development and Tourism, Inclusive Ventures Program
  - \$300,000 Talbot County Parks and Recreation, Frederick Douglass Park on the Tuckahoe Phase II Predevelopment Engineer, Architecture, and Interpretation
  - \$125,000 Talbot County Economic Development and Tourism, Strategic Plan
  - \$750,000 Talbot County Public Works, Goldsborough Neck Road Culvert Replacement Project

Council expressed its appreciation to Ms. Vanhooser, Mr. Jafari, and members of Economic Development Commission application review committee for all the work that went into the making the recommendations.

Upon motion by Mr. Pack, seconded by Mr. Divilio, the Council agreed to forward its recommendations, as agreed upon, by voting 4-0 as follows:

Mr. Lesher recused himself from discussion related to funding a project at the St. Michaels Maritime Museum as he is an employee of the Museum, and Mr. Pack recused himself from discussion related to funding for the Frederick Douglass Park on the Tuckahoe as he is a member of the Frederick Douglass Park on the Tuckahoe Advisory Committee. Mr. Lesher also recused himself from voting.

The County Council will forward the following recommendations, in ranked order, along with a letter of support to Mid-Shore Regional Council by Friday, August 12, 2022:

- \$240,000 Maryland Broadband Cooperative, Inc., Mid-Shore Optical Broadband Network Upgrade
- \$500,000 Eastern Shore Entrepreneurship Center, Ag Biotech Manufacturing Project
- \$500,000 Town of Trappe, Wastewater Treatment Plant Upgrade to ENR Technology
- \$300,000 Chesapeake Bay Maritime Museum, Inc., New Welcome Center
- \$22,000 Talbot County Free Library, Digital Literacy and Employment Skills
- \$87,133 Building African American Minds, Workforce Development Program
- \$50,000 Talbot County Economic Development and Tourism, *Inclusive Ventures Program*
- \$300,000 Talbot County Parks and Recreation, Frederick Douglass Park on the Tuckahoe Phase II Predevelopment, Engineer, Architecture and Interpretation
- \$125,000 Talbot County Economic Development and Tourism, Strategic Plan
- \$750,000 Talbot County Public Works, Goldsborough Neck Road Culvert Replacement Project
- \$38,700 Talbot County Economic Development and Tourism, Visitors Center Feasibility Study
- \$13,000 Oxford Community Center, *Showtime*
- \$50,000 Classic Motor Museum of St. Michaels, Inc., Automotive Technician Apprenticeship Program

The Council, in its letter to Mid-Shore Regional Council, will also indicate its support for an alternative project, the Avalon Foundation, Inc., *Stoltz Pavilion* - \$500,000, should the review committee find that one of the fourteen projects submitted above does not meet the grant guidelines.

- III. Upon motion by Mr. Divilio, seconded by Mr. Pack, the Council voted to adjourn by voting 4 0 as follows:
