A BILL TO AUTHORIZE A CAPITAL PROJECT FOR THE ACQUISITION OF CERTAIN EQUIPMENT AND AN OFFICE TRAILER FOR THE REPURPOSING CENTER LOCATED AT 28128 ST. MICHAELS ROAD, EASTON, MARYLAND

BE IT ENACTED BY the County Council of Talbot County, Maryland, as follows:

SECTION 1: The acquisition of equipment and an office trailer for the Repurposing Center is hereby authorized as a capital project. The scope of work includes, but is not limited to, the acquisition of: (a) equipment to be used to recycle materials; (b) necessary safety equipment; and (c) an office trailer. Approval of this capital project includes authorization to expend funds, not to exceed the total amount of the appropriation, for all incidental and customary costs and charges associated with, and reasonably necessary for, the design, engineering, construction, acquisition and installation of the equipment and office trailer and the cost of financing secured through leasing or borrowing to complete the project.

SECTION 2: The Talbot County Council is hereby authorized to expend up to \$2,506,000 for the Repurposing Center project. This project is to be funded with long-term leases and/or long-term borrowing in an aggregate amount not to exceed \$2,506,000. The use of such leases and borrowing to finance this project is authorized.

SECTION 3: This Ordinance will take effect sixty (60) calendar days from the date of enactment.
