What Is the CRRF?

- Created by the state legislature as part of the Cannabis Reform Act of 2023
 - Reinvests state cannabis revenue (fees and taxes) into impacted communities
 - Each MD county has a CRRF
 - Focused on reinvestment and repair
 - Administered locally by Talbot Family Network, LMB
 - Overseen by Maryland's Office of Social Equity*



INAUGURAL ROUND

- **First CRRF offering in Talbot**
- Designed as a **learning opportunity** for applicants and administrators
- Emphasis on **alignment, intention, and community impact**




CRRF Purpose

- Address harms from disproportionate enforcement of marijuana laws
 - Strengthen individual, family, and community well-being
 - Expand access to opportunity and resources
 - Build community capacity, leadership, and trust

CRRF is purpose-driven funding grounded in a restorative justice approach.

RESTORATIVE JUSTICE in the context of the CRRF

In this context, the restorative justice approach focuses on **repairing harm and reinvesting in communities that have been disproportionately impacted by prior enforcement of marijuana laws**. Rather than emphasizing punishment, restorative justice prioritizes **healing, accountability, and addressing root causes**, by supporting community-led solutions that strengthen individuals, families, and neighborhoods and create pathways to long-term opportunity.



Communities of Focus

- Disproportionately impacted communities and/or
- Low-income communities

Talbot County may prioritize applications that address both.



Who and Where This Funding Is For

- Funds must benefit Talbot County residents
 - Easton (21601) identified as Talbot County's disproportionately impacted area by the OSE
 - OSE tracked cannabis possession charges from 2013-2022
 - Projects outside Easton must address similar communities of focus



Two Application Pathways

Grant Period 5/1/26 – 6/30/27

- 1. Small Community Grants:** targeted, short-term, more transactional efforts
 - \$10,000 maximum grant award
 - \$50,000 total available
- 2. Community Impact Grants:** larger, more comprehensive strategies
 - Minimum award \$25,000
 - \$150,000 total available

Choose the pathway that fits your scope and readiness.



Centering Lived Experience

- CRRF prioritizes approaches informed by lived experience
 - Community members help shape how a program or strategy is designed and delivered
 - People most affected by the problem are reflected in program design, implementation and/or leadership.



Collaboration & Partnerships

The communities of focus experience interconnected challenges.

- Collaboration is encouraged but not required
 - Strong partnerships add value and shared accountability
 - Provide documentation of the partnership (e.g. MOU)
 - If not partnering, explain why your approach is effective to stand alone



Outcomes, Learning & Impact

- What will change as a result of this work?
 - How will you know the work is making a difference / having the intended impact?
 - If this, then what?
 - Intentional efforts to assess impact matter more than sophisticated evaluation systems.



Reporting & Data Collection

- CRRF grantees are expected to report on activities, outcomes, and use of funds
- Reporting requirements are scaled to the funding pathway
- Grantees must have capacity to collect basic program data, including participant information disaggregated by race and ethnicity
- Data collection does not require specialized software—simple spreadsheets and basic tools are sufficient
- TFN provides reporting templates



Budget Basics

- Per Maryland Statute – Funds may not be used for
 - Law enforcement agencies or activities, or
 - To supplant funding that was already budgeted for existing local government programs.
- Budget form is calculation-based
 - Costs must align with proposed activities




This is an example of calculation

- Food: \$20pp x 25 people x 2 outreach events = \$1,000




This is not a calculation

- Food: food for 2 events



Review Process

- Applications reviewed by a TFN Board committee
 - Scoring emphasizes CRRF alignment and community connection
 - The scoring rubric for each pathway will be posted on the webpage by the end of February 2026
